**CONSENT ORDER**

**Respondent.**

The State of Arizona Department of Insurance ("Department") has received evidence that **Jason Adams Roque** ("**Respondent**") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Jason Adams Roque ("Roque") is, and was at all material times, licensed as an Arizona resident bail bond agent, Arizona license number 17570622, which expires on June 30, 2022.
2. Roque's address of record is: c/o Alliance Bail Bond Services, 1013 S Stapley Dr, Mesa, AZ, 85204 (business and mailing) and ALLIANCEBAILBONDS2016@GMAIL.COM.
3. Roque's license expired on June 30, 2018.
4. From on or about June 30, 2018 through December 12, 2018, Roque sold, solicited, and negotiated at least eight (8) bail bond transactions.

1 **CONCLUSIONS OF LAW**

2 1. The Director has jurisdiction over this matter.

3 2. Roque's conduct, as described above, constitutes acting as a bail bond agent  
4 within this State without being licensed by the Director, within the meaning of A.R.S. § 20-  
5 340.01(A).

6 3. Roque's conduct, as described above, constitutes a violation of Title 20, within  
7 the meaning of A.R.S. §§ 20-295(A)(2) as applied to bail bond agents under A.R.S. §§ 20-  
8 340.06.


9 4. Grounds exist for the Director, in addition to or instead of any suspension,  
10 revocation or refusal to renew, impose a civil penalty of not more than two hundred fifty dollars  
11 for each unintentional failure or violation, up to an aggregate civil penalty of two thousand five  
12 hundred dollars, or impose a civil penalty of not more than two thousand five hundred dollars  
13 for each intentional failure or violation, up to an aggregate civil penalty of fifteen thousand  
14 dollars, within the meaning of A.R.S. §§ 20-295(F).

16 **ORDER**

17 IT IS HEREBY ORDERED THAT:

18 1. Respondent shall immediately pay a civil penalty of \$800.00 for deposit into the  
19 State General Fund.

1 **CONSENT TO ORDER**

2 1. Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law and  
3 Order.

4 2. Respondent admits the jurisdiction of the Director of Insurance, State of Arizona,  
5 and admits the foregoing Findings of Fact and consents to the entry of the foregoing  
6 Conclusions of Law and Order.

7 3. Respondent is aware of his right to notice and to a hearing, at which he may be  
8 represented by counsel, present evidence and examine witnesses. Respondent irrevocably  
9 waives his right to such notice and hearing and to any court appeals relating to this Consent  
10 Order.

11 4. Respondent states that no promise of any kind or nature whatsoever, except as  
12 expressly contained in this Consent Order, was made to him to induce him to enter into this  
13 Consent Order and that he has entered into this Consent Order voluntarily.

14 5. Respondent acknowledges that the acceptance of this Consent Order by the  
15 Director is solely to settle this matter against him and does not preclude any other agency,  
16 officer, or subdivision of this state including the Department from instituting civil or criminal  
17 proceedings as may be appropriate now or in the future.

18 6. Respondent acknowledges that this Consent Order is an administrative action  
19 that the Department will report to the National Association of Insurance Commissioners (NAIC)  
20 and that he may have to report this administrative action on any future licensing applications  
21 either to the Department or other states' Departments of Insurance.
