CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Omar Leonardo Hernandez ("Respondent") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true, and consents to the entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Omar Leonardo Hernandez ("Respondent") is licensed as an Arizona resident insurance producer with lines of authority in property and casualty insurance, National Producer Number 19075103. Respondent's license expires on September 30, 2022.

1 4. Respondent states that no promise of any kind or nature whatsoever,
2 except as expressly contained in this Consent Order, was made to him to induce him to
3 enter this Consent Order and that he has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by
5 the Director is solely to settle this matter against him and does not preclude any other
6 agency, officer, or subdivision of this state including the Department from instituting civil
7 or criminal proceedings as may be appropriate now or in the future not related to this
8 matter.

9 6. Respondent acknowledges that this Consent Order is an administrative
10 action that the Department will report to the National Association of Insurance
11 Commissioners (NAIC). Respondent further acknowledges that he must report his
12 administrative action to any and all states in which he holds an insurance license and
13 must disclose this administrative action on any license application.
