ORDER TO CEASE AND DESIST

The State of Arizona Department of Insurance ("Department") has received evidence that **First and Last Insurance Services Inc.** and **Narek Gagikovich Harutyunyan** ("Respondents") unlawfully sold, solicited, or negotiated an insurance contract in the State of Arizona. Accordingly, the Director of Insurance of the State of Arizona (the "Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. § 20-292.

FINDINGS OF FACT

- 1. First and Last Insurance Services, Inc. ("First and Last"), is a California business entity¹, which is not licensed to transact insurance in the State of Arizona. First and Last is licensed to transact casualty and property insurance in California under license no. 0K53919.
- First and Last is not a duly organized foreign company or corporation in the State of Arizona.
- First and Last's known address, per the California Department of Insurance ("CDOI") website, is: 350 North Lantana Street, Camarillo, California 93010.

¹ First and Last Insurance Services, Inc. changed its name from Hollywood's Best Insurance Services, Inc. on October 8, 2015.

- 4. Per the CDOI website, Narek Gagikovich Harutyunyan ("Harutyunyan") is listed as the sole endorsed agent affiliated with First and Last and holds a license with the CDOI as property and casualty producer, license no. 0I42746.
- 5. Per the California Secretary of State, Narek Harutyunyan, is listed as the sole officer and statutory agent of First and Last.
- 6. Harutyunyan is licensed with the Department as a non-resident property and casualty insurance producer, National Producer No. 17003584. Harutyunyan's license expires on August 31, 2021. Harutyunyan's addresses of record are: 1601 Carmen Drive, 201, Camarillo, CA 93010 (business); 5411 Hollywood Blvd., 513, Los Angeles, CA 90027 (mailing) and erik@firstins.org (business e-mail).
 - 7. First and Last is not exempt from the licensing requirement in Arizona.
- 8. On or about December 6, 2017, the Department received information that First and Last transacted a policy of insurance for A & C Transportation LLC, a Yuma, Arizona company.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondents' conduct, as alleged above, constitutes selling, soliciting or negotiating insurance in this state for any class or classes of insurance without being licensed for that line of authority, within the meaning of A.R.S. § 20-282.
- 3. First and Last is not exempt from the licensing requirement, within the meaning of A.R.S. § 20-283.
