Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance ("Department"), the Director finds as follows:

FINDINGS OF FACT

- Transamerica Advisors Life Insurance Company ("Petitioner") is an Arkansas domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective August 28, 1986.
- 2. Effective July 1, 2019, Petitioner, the non-surviving entity, merged into Transamerica Life Insurance Company (TLIC), NAIC No. 86231, an Iowa domiciled insurer and the surviving entity. TLIC is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- 3. The Insurance Commissioner of Arkansas approved the merger of Petitioner into TLIC on May 31, 2019.
- 4. Petitioner has no outstanding obligations under any policy of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants who are residents of this State.
