CONSENT ORDER

Respondent.

The State of Arizona Department of Insurance ("Department") has received evidence that **Hilary Ann Parks** ("Parks" or "Respondent") violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Parks was, at all material times, licensed as an Arizona resident insurance producer with a single line of authority: life insurance. The Department renewed Park's license, number 17181146¹, on April 24, 2017. The license is scheduled to expire on April 30, 2021.

1 unintentional failure or violation, up to an aggregate civil penalty of \$2,500.00, or impose a
2 civil penalty of not more than \$2,500.00 for each intentional failure or violation, up to an
3 aggregate penalty of \$15,000.00, or order the licensee to provide restitution to any party
4 injured by the licensee's action, pursuant to A.R.S. § 20-295(F).

5 **ORDER**


6 IT IS HEREBY ORDERED THAT:

7 1. **Hilary Ann Parks**, National Producer Number 17181146, shall immediately pay
8 restitution in the amount of \$871.00 to Ruth Torrisi and provide proof of the restitution
9 payment to the Department.

10 2. **Hilary Ann Parks**, National Producer Number 17181146, shall immediately pay
11 a civil penalty of \$2,750 for deposit into the state general fund.

12 3. The insurance producer license of **Hilary Ann Parks**, National Producer
13 Number 17181146, is revoked, effective immediately.

1 3. Respondent is aware of her right to notice and to a hearing, at which she may
2 be represented by counsel, present evidence and examine witnesses. Respondent
3 irrevocably waives her right to such notice and hearing and to any court appeals relating to
4 this Consent Order.

5 4. Respondent states that no promise of any kind or nature whatsoever, except as
6 expressly contained in this Consent Order, was made to her to induce her to enter into this
7 Consent Order and that she has entered into this Consent Order voluntarily.

8 5. Respondent acknowledges that the acceptance of this Consent Order by the
9 Director is solely to settle this matter against her and does not preclude any other agency,
10 officer, or subdivision of this state including the Department from instituting civil or criminal
11 proceedings as may be appropriate now or in the future.

12 6. Respondent acknowledges that this Consent Order is an administrative action
13 that the Department will report to the National Association of Insurance Commissioners
14 (NAIC) and that she may have to report this administrative action on any future licensing
15 applications either to the Department or other states' Departments of Insurance.
