CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **EDNM Financial Services LLC dba Express Insurance Center ("Express")** and **Dylia Doribel Hernandez ("Hernandez")** violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondents wish to resolve this matter without the commencement of formal proceedings, admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Express is, and was at all material times, an Arizona business entity that is licensed as a property and casualty insurance producer. The Department issued Express a license, number 18588556, on October 29, 2017. The license is scheduled to expire on October 31, 2021.
