11 The State of Arizona Department of Insurance ("Department") has received evidence
12 that **Jason Alan Wade and Regina Marie Wade** (collectively the "Respondents") violated
13 provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondents wish to resolve this
14 matter without the commencement of formal proceedings, and admit the following Findings of
15 Fact are true and consent to entry of the following Conclusions of Law and Order.

16 **FINDINGS OF FACT**

17 1. Jason Alan Wade ("Jason") was, at all material times, licensed as an Arizona
18 resident insurance producer. On July 29, 2004, the Department issued to Jason a license,
19 number 8179666, with a single line of authority as a life insurance producer. The license last
20 renewed effective January 1, 2016 and is scheduled to expire on December 31, 2019.

21 2. Regina Marie Wade ("Regina") was, at all material times, licensed as an Arizona
22 resident insurance producer. On August 19, 2016, the Department issued to Regina a license,
23 number 18072787, with a single line of authority as a life insurance producer. The license is
24 scheduled to expire on December 31, 2019.

1 **CONCLUSIONS OF LAW**

2 1. The Director has jurisdiction over this matter.

3 2. Respondents' conduct, as described above, constitutes a violation of Title 20,
4 within the meaning of A.R.S. § 20-295(A)(2).

5 3. Respondents' conduct, as described above, constitutes using dishonest practices
6 in the conduct of business in this state or elsewhere, within the meaning of
7 A.R.S. § 20- 295(A)(8).

8 4. Respondents' conduct, as described above, constitutes presenting, causing to be
9 presented or preparing with the knowledge or belief that it will be presented an oral or written
10 statement, including computer generated documents, to or by an insurer, reinsurer, purported
11 insurer or reinsurer, insurance producer or agent of a reinsurer that contains untrue statements
12 of material fact with respect to an application for the issuance or renewal of an insurance policy,
13 within the meaning of A.R.S. § 20-463(A)(1)(a).

14 5.. Grounds exist for the Director to deny, suspend for not more than twelve months,
15 revoke or refuse to renew an insurance producer's license, or to impose a civil penalty or any
16 combination of actions, within the meaning of A.R.S. § 20-295(A) and (F).

17 **ORDER**

18 IT IS HEREBY ORDERED THAT:

19 1. Jason Alan Wade shall immediately pay a civil penalty in the amount of \$250.00
20 or deposit into the state general fund.
