Nassau Life Insurance Company of Texas (NLICT), NAIC No. 62359, a Texas domiciled insurer and the surviving entity. NLICT is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- 3. The Insurance Commissioner of Pennsylvania approved the merger of Petitioner into NLICT on September 25, 2019.
- 4. Petitioner has no outstanding obligations under any policy of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants who are residents of this State.
