**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE AND
NOTICE OF OPPORTUNITY FOR
HEARING**

The Arizona Department of Insurance (the “Department”) alleges that **Christopher Lee Pippin** has violated provisions of Arizona Revised Statutes (“A.R.S.”), Title 20. In light of the serious nature of these allegations, the Director of the Arizona Department of Insurance (“Director”) finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Christopher Lee Pippin (“Respondent”) is licensed as an Arizona resident bail bond agent, National Producer Number 18168307. Respondent’s license is scheduled to expire on January 31, 2020.

2. Respondent’s address of record with the Department is 10434 North 42nd Place, Phoenix, AZ 85028, and his business email address is emergencybailbonding@gmail.com.


3. On or after January 24, 2019, the Department received a Notice of Cancellation (the “Notice”) from Bankers Insurance Company. The Notice informed the Department that the License & Permit (Surety) Bond, associated with Christopher Pippin “is hereby canceled ... due to the company’s request. ... effective as of February 23, 2019.”

1 **ORDER**

2 IT IS HEREBY ORDERED THAT:

3 1. Respondent's bail bond agent license, National Producer Number 18168307 is
4 summarily suspended, effective immediately.


