- 1. Landcar Life Insurance Company ("Petitioner") is a Utah domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective January 16, 1981.
- 2. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of authority to the Director.
- 3. Petitioner has outstanding obligations under policies of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants who are residents of this State.
- 4. Petitioner is not the subject of any pending investigation or market conduct examination and does not owe this Department any filings or fees.
