12	Articles of Dissolution with the ACC on or before December 31, 2020
13	5. Petitioner shall pay its Certificate of Authority renewal fee to the Department
14	unless it files Articles of Dissolution with the ACC on or before March 31, 2021.
15	6. The Department shall refund to the Petitioner the \$100.00 that was previously
16	credited to the IERF pursuant to A.R.S. § 20-159.
