FINDINGS OF FACT

1. Petitioner is currently licensed in the State of Arizona as a captive insurer.

2. Petitioner surrendered its Certificate of Authority to the Department.

3. Petitioner filed with the Department certified copies of Resolutions of the

Petitioner's Board of Directors and the Petitioner's shareholder(s) authorizing Petitioner to

withdraw from the insurance business and to file its Statement of Domestication/Articles of

Redomestication or equivalent document.

4. Petitioner filed its certified financial statement as of August 2, 2023 with the Department.

5. Petitioner has outstanding obligations under policies of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants. Petitioner's insurance obligations shall be an obligation of the redomesticated insurer upon redomestication.

Petitioner has a \$100.00 deposit with the Insurance Examiners' Revolving Fund 1 ("IERF"). 2 CONCLUSIONS OF LAW 3 Petitioner has complied with the provisions of A.R.S. § 20-217, Title 20, Chapter 4, 4 Article 14 and with A.A.C. R20-6-303 relating to the surrender of its Certificate of Authority and 5 6 its withdrawal from the insurance business. ORDER 7 1. Petitioner's request to terminate its Certificate of Authority is granted. 8 2. Petitioner may file its Statement of Domestication/Articles of Redomestication or 9 equivalent document with the Arizona Corporation Commission ("ACC"). 10 3. Petitioner shall provide the Department with an ACC certified copy of Petitioner's 11 ACC filed Statement of Domestication/Articles of Redomestication or equivalent document. 12 4. Petitioner shall file its 2023 Annual Report with the Department unless it files the 13 Statement of Domestication/Articles of Redomestication or equivalent document with the ACC 14 on or before December 31, 2023 15 5. Petitioner shall pay its Certificate of Authority renewal fee to the Department 16 unless it files the Statement of Domestication/Articles of Redomestication or equivalent 17 document with the ACC on or before March 31, 2024. 18 6.
