- 1. Physicians Insurance A Mutual Company ("Petitioner") is a Washington domiciled insurance company that received its certificate of reinsurance accreditation to transact reinsurance in Arizona effective February 22, 2021.
- 2. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of reinsurance accreditation to the Director.
- 3. Petitioner has no outstanding obligations under any policy of insurance to policyholders or claimants who are residents of this State and does not currently assume risk from any Arizona domestic insurer, and is not a party to any reinsurance agreement with an Arizona domestic insurer.
- Petitioner is not the subject of any pending investigation or market conduct 4. examination and does not owe this Department any filings or fees.
