Based upon reliable evidence provided to the Cabinet Executive Officer/Executive Deputy Director of Insurance and Financial Institutions by the Deputy Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance and Financial Institutions ("Department"), the Department finds as follows:

- 1. Citizens National Life Insurance Company ("Petitioner") is a Texas domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective January 20, 1987.
- 2. Effective July 1, 2023, Petitioner, the non-surviving entity, merged into CICA Life Insurance Company of America (CICA), NAIC No. 71463, a Colorado domiciled insurer and the surviving entity. CICA is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- 3. The Insurance Commissioner of Texas approved the merger of Petitioner into CICA on June 12, 2023.
