This matter regularly came on for hearing at the Department of Insurance at which hearing the Department was represented by Michael R. Schaffert, Assistant Attorney General. Notice of the hearing was mailed to the Respondent at her last known address of record in the Department of Insurance but the Respondent did not appear either in person or by counsel. Testimony and evidence were submitted and it is found as follows:

1. At the time of the occurrence of the alleged conduct, the Respondent was a licensed insurance agent.
2. The Respondent received adequate and sufficient notice of the hearing.
3. The Respondent accepted money from Clarissa Lewis, doing business as Culver Electric, for premium for a commercial insurance policy. The Respondent failed to forward the premium to any insurance company and has not reimbursed Ms. Lewis or any insurer.

IT IS CONCLUDED as a matter of law that the Respondent has misappropriated, converted or illegally withheld monies belonging to a policyholder or an insurer in violation of A.R.S. § 20-316. It is further concluded that grounds exist to suspend


1 or revoke the Respondent's license, impose a monetary forfeiture
2 or both pursuant to A.R.S. § 20-316.

3 IT IS HEREBY ORDERED revoking any and all licenses of
4 the Respondent.

5 The Respondent may request a review or a rehearing of
6 this matter by making such request in writing setting forth the
7 grounds therefor and the relief requested within thirty (30) days
8 of the date of this Order.
