Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Corporate and Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, Connecticut Mutual Life Insurance Company, NAIC No. 62316, is a foreign insurer domiciled in Connecticut. Petitioner received its certificate of authority to transact life and disability insurance in Arizona on October 1, 1955.

2. Effective February 29, 1996, Petitioner, the non-surviving entity, merged into Massachusetts Mutual Life Insurance Company ("Massachusetts Mutual"), the surviving entity, a foreign insurer domiciled in Massachusetts. Petitioner has voluntarily surrendered its certificate of authority to the Director.

3. On February 14, 1996, the Insurance Commissioner of Connecticut approved the merger of Petitioner into Massachusetts Mutual.

6 not owe this Department any filings or fees.


7 6. Petitioner has deposited \$100.00 which has been

13 2. The \$100.00 deposited by Petitioner which has been
14 credited to the IERF shall be released to Petitioner.
