ORDER

Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Corporate and Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, Pioneer National Life Insurance Company, NAIC No. 67938, is a foreign insurer domiciled in Kansas. Petitioner received its certificate of authority to transact life and disability insurance in Arizona on October 3, 1984.

2. Effective September 8, 1995, Petitioner, the non-surviving entity, merged into First Security Benefit Life Insurance & Annuity Company of New York ("First Security"), the surviving entity, a foreign insurer domiciled in New York. Petitioner has voluntarily surrendered its certificate of authority to the Director.

3. On May 24, 1995, the Insurance Commissioner of Kansas approved the merger of Petitioner into First Security.

4. Petitioner has no obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.

1 5. Petitioner is not the subject of any pending
2 investigation or market conduct examination, and Petitioner does
3 not owe this Department any filings or fees.


4 6. Petitioner has deposited \$100.00 which has been
5 credited to the Insurance Examiners' Revolving Fund ("IERF")
6 pursuant to A.R.S. §20-159.

7 IT IS ORDERED that:

8 1. The surrender of the Petitioner's certificate of
9 authority is accepted.

10 2. The \$100.00 deposited by Petitioner which has been
11 credited to the IERF shall be released to Petitioner.
