#### 7. The current status of the proposed rule.

The Department opened the Docket on the proposed rule on October 18, 2024. This allowed it to discuss the proposed rules with various stakeholders. On November 8, 2024, the Department published a Notice of Informal Meeting on Open Rulemaking (30 A.A.C. 3333, November 8, 2024) and met with the Pharmaceutical Care Management Association on November 14, 2024. On March 7, 2025, the Department published a second Notice of Informal Meeting on Open Rulemaking (31 A.A.C. 737, March 7, 2025) and met with pharmacist groups interested in the rulemaking on April 8, 2025. Both meetings were also published on the Department's meeting webpage (https://difi.az.gov/meeting) and the ADOA Public Meeting website (https://publicmeetings.az.gov/). At the Governor's request, the Department reached out to consumer groups for comment on April 15, 2025 (Patients for Affordable Drugs, and the Association for Accessible Medicines) and April 23, 2025 (the Arizona Chronic Care Together Coalition). None of these groups has responded to the Department's efforts.

The Department is now ready to submit the Notice of Proposed Rulemaking to the Secretary of State's Office for publication.
