1 Total number of inquiries regarding dispute resolution of SOON bills received in Calendar Year 2022 427

2 Of the requests resolved in CY 2022, number that did not qualify for dispute resolution 227

> Coverage was from a self-funded plan, exempted by ARS § 20-3112(6) from qualification. Self-funded plans, also referred to as ERISA plans, are not insurance (and not subject to Arizona law). They are plans for which an employer contracts with an administrator to collect premiums and pay claims on the employer's behalf. 41

> Surprise bill was not at least \$1,000 as required by ARS § 20-3114(A)(3). 28

> Coverage was through a health care service organization (a.k.a. "HMO"). ARS § 20-3111(11) excludes HMO plans because an HMO pays non-contracted providers when a member obtains a covered health care service in a contracted facility. 19

> Health care service was rendered prior to January 1, 2019, the effective date of Title 20, Chapter 20, Article 2. 0

> Coverage was provided by a federal employee health plan, which is not subject to Arizona law. 5

> The healthcare service was not provided in a health care facility as defined in ARS §§ 20-3111(8) and 36-437. 10

> The enrollee failed to participate in the informal settlement teleconference as required by ARS § 20-3114(B). 1

> Coverage was from a limited benefit plan, exempted by ARS § 20-3112(2) from qualification. 2

> The number settled during an informal settlement teleconference. 172

> The number settled after qualification but before an informal settlement teleconference. 33
