## Mortgage Broker Test Registration Information

**NOTE: Pursuant to A.R.S. 6-908(C) an applicant may not take the mortgage broker test more than two (2) times within a twelve (12) month period.**

**Location & Time:** Tests are held at **100 North 15th Avenue**. DIFI's main guest parking has a maximum parking allowance of 2 hours. To avoid any tickets please park in the overflow lot located on the northeast corner of 15th Avenue and West Adams Street.

**\*\*\*No one will be admitted to the test site 15 minutes after the training room opens\*\*\***

**To REGISTER:** Begin by going to <https://elicense.az.gov>. Step #1 - Click the "LOG IN" option. Step #2 - Click the "I DON'T HAVE A LICENSE" button. Step #3 - Enter Your Personal Contact Information. Step #4 - Create A Password (per the password specifications). #5 - Click the "SUBMIT" button. Once you have registered, login using the email address and password you just entered. Once logged in, click the "CLICK HERE TO APPLY FOR NEW LICENSES" button. Select "Board" (Arizona Department of Financial Institutions), then select "License Type" (Mortgage Broker Test), then select "Application By" (General Application). Click the "SAVE AND CONTINUE" button and continue through the remainder of the application. You DO NOT need to fill out your education history, employment history, or declarations. You are required to submit a copy of school "Certificate of Completion" and the \$50 test fee via the online portal application. **TO RESCHEDULE AN EXAM THAT HAS BEEN SUBMITTED TO THE DEPARTMENT:** Send an email to [FElicensing@difi.az.gov](mailto:FElicensing@difi.az.gov) requesting that your exam date be rescheduled.

**Day of test:** Candidates must bring one form of identification (form must be a picture ID). You will be required to sign in before taking the test.

**Items:** Candidates should bring a non-database type financial calculator, at least 2-3 #2 pencils (sharpened) and an eraser. The Department will furnish all test materials including scratch paper. **A CALCULATOR WILL NOT BE PROVIDED FOR YOU.**
