**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **David Anthony Sandoval** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT


1. David Anthony Sandoval ("Respondent") is licensed as a bail bond agent, Arizona License Number 117280 which expires on June 30, 2009.
2. Respondent's addresses of record with the Department are: dba Sandoval's Bail Bond, 2707 N. Columbus Blvd., Tucson, Arizona 85712 (business and residence); and P.O. Box 31738, Tucson, Arizona 85751(mailing).
3. On November 16, 2006, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on December 16, 2006.

3 1. Respondent's license is summarily suspended effective immediately.



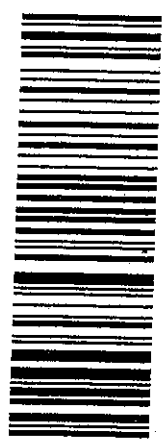
