- 2. On September 3, 2010, the Director issued an order suspending the certificate of authority of Respondent based upon Respondent's failure to file its: (a) 2009 Annual Statement; (b) Annual certification, and (c) Certificate of Disclosure.
- 3. Respondent filed an application for reinstatement on November 29, 2010 and based upon the Respondent's filing of its: (a) 2009 Annual Statement; (b) Annual certification, and (c) Certificate of Disclosure, Respondent has corrected all deficiencies and meets the requirements for the authority granted.

4.	Respondent is current in regard to all filings and fees required to be made to the
Department :	and owes no outstanding fines and penalties.
