**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Brett Kenneth Hall** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Brett Kenneth Hall ("Respondent") is licensed as a resident bail bond agent, Arizona license number 967749 which expires on September 30, 2013.
2. Respondent's addresses of record are: 1010 E. Indian School Rd., Phoenix, Arizona 85014 (business and mailing); and 1001 E. Brae Burn Dr., Phoenix, Arizona 85022 (residence).
3. On January 27, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days after receipt of the notice.
