**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Thomas Barrett Jones** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Thomas Barrett Jones ("Respondent") is licensed as a resident bail bond agent, Arizona license number 153410 which expires on April 30, 2013.

2. Respondent's addresses of record are: c/o True Grit Bonding, 1520 N. Scottsdale Rd., Tempe, Arizona 85281 (business); P.O. Box 24002, Tempe, Arizona 85285 (mailing); and 2454 E. Camino St., Mesa, Arizona 85213 (residence).

3. On March 16, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on April 10, 2011.
