AMENDED NOTICE OF COMBINED ANNUAL PUBLIC MEETING AND EXECUTIVE SESSION OF THE BOARD OF DIRECTORS OF THE ARIZONA LIFE AND DISABILITY INSURANCE GUARANTY FUND (FUND)

TUESDAY, NOVEMBER 4, 2014

Pursuant to A.R.S. § 38-431.02 and A.R.S. § 20-690(B), Notice is hereby given to the Members of the Board of Directors of the Arizona Life and Disability Insurance Guaranty Fund and to the General Public that the Board of Directors of the Arizona Life and Disability Insurance Guaranty Fund (Fund) will hold its Annual Meeting, which meeting will be open to the Public, at 10:00 a.m., Tuesday, November 4, 2014, at 1110 W. Washington Street, Suite 250 (ADEQ Building Conference Room), Phoenix, Arizona 85007.

Some members of the Board may attend the meeting telephonically.

As indicated in the Agenda, the Board of the Arizona Life and Disability Insurance Guaranty Fund may vote to go into Executive Session, which will not be open to the public, to discuss certain matters.

The agenda for the meeting is as follows:

- 7. Discussion, consideration and possible action concerning the potential obligations of the Fund with respect to an impaired insurer and an Executive Session pursuant to A.R.S. § 20-690(B) and A.R.S. § 38-431.03(A)(3) to confer with counsel concerning the matter.
- 8. Report from the Executive Director, discussion and possible action regarding the following:
 - A. Discussion and possible action concerning ratification of the Executive Director's decision to pay NOLHGA assessments for the first and second quarters of 2014 in the amounts of \$127,460.00 and \$140,121.00, respectively;
 - B. Review of the Fund's Plan of Operation, discussion and possible action concerning any suggested amendments thereof;
 - C. Review, discussion and possible action regarding the status of contracts with servicing facilities;
 - D. Review, discussion and possible action concerning the balance in the Fund's accounts.
- 9. Additional Executive Session(s), if necessary, pursuant to A.R.S. § 38-431.03(A)(3), to confer with counsel concerning legal issues in connection with any item included within this Notice and Agenda.

- 10. Determination of the Date, Time and Place of the Board meetings to be held during the ensuing year.
- 11. Call to the Public: This is the time for the public to comment. Members of the Board may not discuss items that are not on the Agenda. Therefore, action taken as a result of any public comment will be limited to directing staff to study the matter or scheduling the matter for further discussion and decision at a later date.
